### Pennsylvania Brings in \$2.64 Billion in Revenue Collections

General Fund revenue collections for the month of January were \$2.64 billion, which was \$50 million less than expected.

Collections of \$105 million for corporation taxes came in below Department of Revenue projections by \$60.4 million. Sales tax collections of \$914 million were lower than expected, coming in \$5 million below the official estimate. The Personal Income Taxes collected were \$1.29 billion, which was above estimate by \$27 million.

For the 2016-17 Fiscal Year, General Fund collections of \$16.1 billion are below the official estimate by \$417 million.



### **Chairman's Budget News**

Recently, Governor Wolf has announced a series of cost containment measures aimed at addressing the large structural deficit that the Commonwealth faces. The governor announced that he is seeking to com-bine the Department of Human Services, Department of Health, Department of Drug & Alcohol Programs, and the Department of Aging into one department to be known as the Department of Health and Human Services. The governor did not provide a dollar amount for the savings that would result from this merger. This month the governor also announced the closing of SCI-Pittsburgh, a state correctional facility located in Allegheny County. According to the Administration, the closure of this prison will result in a projected \$81 million annual savings for Pennsylvania.

Additionally the governor announced that he will be working with the Treasury Department to consolidate some funds to save \$5.6 million. The governor has indicated he will be eliminating thousands of unfilled jobs and he will be working to consolidate information technology and human resources across state agencies.

These announcements are a step in the right direction as we seek to restructure state government to ensure we are operating in the most fiscally responsible manner. It is important that the governor's plans for these initiatives are thoroughly vetted to make sure that the current plans will result in actual savings. Simply combining departments without eliminating duplicative positions and not getting rid of unneeded real-estate is not in the best interest of Pennsylvania taxpayers.
